# 1. My Life in Gotemba with Fuji-san G-coins

Fuji-san G-coins have been in use for 1 and half years, since the summer of 2022. Approximately 1 in 2 citizens now use it, and there are over 350 stores/businesses where G-coins can be used in the city now. We will continue to aim to become an even more beloved digital currency.

## \*Scene 01: Marriage/ Childbirth

Marriage life support:

To support married life, 50,000 dollars will be given to couples who married after April 1<sup>st</sup>, 2023. Inquiry: Commerce and industry promotion division at (82)4683

• Childbirth/ Childcare support:

As a birth celebration and childcare support, 20,000 dollars is provided to children who were born on or after April 1<sup>st</sup>, 2022.

# \*Scene 02: Health

Body vitality program:

500 dollars for those who have undergone a specific medical examination under the National Health Insurance. 500 dollars for those who receive subsequent specific health guidance. (Total: 1,000 dollars)

• Gotemba health mileage achievement benefits:

500 dollars will be given to those who have been issued a "Fuii-no-Kuni Health card".

### \*Scene 03: Education

• Entrance celebrations to Elementary/ Jr. High school in Gotemba

10,000 dollars will be given to households with a Gotemba city resident, who will enroll in elementary/ Jr. high school, for the 2023 school year as of April 1<sup>st</sup>, 2023.

### \*Scene 04: Child rearing

Support for low-income child-rearing households

In order to provide a better child-rearing environment, special government subsidy will be given to support low-income child-rearing households.

#### \*Scene 05: Respect for the elderly

• Celebration of 77, 88 and over 100 years-old.

As a celebration of healthy longevity, 10,000 dollars will be given to people who will turn 77, 88 and 100, 101 or older.

#### \*Scene 06: Sports

Sports awards

1,000 to 30,000 dollars will be given to those who participate in competitions that fall under the city's sports award grant guidelines.

• "I Love Sports" achievement celebration

Award recipients will receive between 500 to 2,000 dollars for "I Love Sports competition".

#### \*Scene 07: Environment

• 5,000 to 10,000 dollars will be given to those who have installed multiple products at the same time of auxiliary equipment targeted for introduction support projects such as household regional decarbonization transition promotion equipment, etc. (ex. #### \*Scene 08: Events

City events

Participation points will be given to those who participate in Eki-maeru, Industrial fair, Local events (Inno cultural festival, dream festival Tamaho etc.)

School events

Available to pay at Gotemba high school cultural festival, Go-ko Shop G-shop based on students' ideas.

#### \*Scene 09: Premium Fuji-san G-coin is on sale!

Premium Fuji-san G-coins have been sold 4 times so far.

G-coins are currently on sale during the year-end and New Year holidays with a premium rate of 30%. (Sales ends Wednesday, January 31st)

# 2. Support Benefit for ¥70,000/ household To All Residents Tax-Exempt Households, etc.

(\*You need to take the following procedures to receive the benefit.)



City homepage:

City provides ¥70,000per household to households exempt from resident tax as support to reduce the burden of rising prices of food, energy, etc.

Inquiry: Social Welfare Division at (70)3223

- Eligible households (You can't get duplicate benefits from both ① and ②)
  - ① Registered in Gotemba as of Dec. 1, 2023 and all members of the household are exempt from resident tax for 2023.

Household members dependent on relatives capable of paying resident tax are not eligible. (Such as a student who is dependent on a parent or a parent dependent on their child)

Procedures to receive the benefit

We will send a confirmation letter to the target household by the middle of January.

Please check the contents and reply with the enclosed envelope.

② Households experiencing a sudden income drop
Among households other than exempt from resident tax, Households members whose
combined financial situation is equivalent to non-taxable income\* due to a sudden income
drop from January to December in 2023.

{All family's expected annual income (12 times of any monthly income after Jan. 2023) is equivalent to non-taxable households}

Annual salary income estimate...930, 000yen for a single person, 2,040,000yen for a single parent

Procedures to receive your benefit

You need to submit your application with your ID copy and any document showing income (such as salary slip etc.) to the city.

- Application forms will be posted on the city homepage by the middle of January and distributed to social welfare division, city hall branches, social welfare council.
- Application period: <u>Friday</u>, <u>May 31<sup>st</sup></u>, <u>2024</u>.

if eligible households receive the confirmation letter, please return it by the deadline. Beware of "bank transfer scams" and "exploitation of personal information". If you receive a suspicious phone call or anything, please contact the city's consumer life center at (83)1629 or Gotemba police station at (84)0110.

# 3. Let's Consider Purchasing a Sunto Area Mutual Aid Traffic Accident Insurance Plan for the Entire Family.

Inquiry: Community safety section at (82)4123.

This insurance plan compensates Gotemba, Susono, Oyama, Nagaizumi and Shimizu residents. It is a mutual aid system for anyone unfortunately involved in a traffic accident.

- Coverage period: From Monday, April 1st, 2024 to Monday, March 31st, 2025
- Eligibility: Gotemba registered residents

XIn the case you move out from Gotemba during this period, you are still eligible to be a member. 

✓

- Fee: The premium is 500 yen (1 year) per person.
  - XYou can join up to 2 shares.
  - \*Later on the April 1st enrollment will be still same fee.
- Application submit period: By Sunday, March 31<sup>st</sup>
   ※You can apply after April 1<sup>st</sup> on an as needed basis, but coverage start the day after the premium is paid.
- How to enroll:

Please submit your mailed application to financial institutions within the city (excluding post offices). XYour community association leader will not be collecting.

How to receive compensation money:

Claims must be made within two years following the day of the accident, and submit the necessary documentation shown below to Community safety section.

- ① Designated consolation payment claim form by Sunto area mutual aid traffic accident insurance plan.
- ② Traffic accident certificate (Copy is available.)
- ③ Certificate of treatment which specifies injury date, reason and name of illness, visitation/hospitalized date. (Copy is available)
